COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Final Development Plat of Greco Bend Subdivision in accordance to the Kendall County Development Rules and Regulations. The proposed residential subdivision would create 23 lots for an average density of 6.1 acres per lot and 2,980 linear feet of roadway.
