COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to grant relief from lot size and platting requirements in accordance to Sections 101 and 102 of the Kendall County Development Rules and Regulations for the proposed family division to create a 3-acre tract of land out of a parent tract of approximately 123 acres (40 Jones Cemetary Road - Karen Ann Herrin Buckelew).

Motion was made by Commissioner Chapman, seconded by Commissioner Bergmann, and carried by a vote of 5-0.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to grant relief from lot size and platting requirements in accordance to Sections 101 and 102 of the Kendall County Development Rules and Regulations for an existing 2.76-acre tract (10897 US Hwy 87 - Sherry Scott).
