If you enter a plea of Not Guilty, you must make an appearance before the Court or enter your plea in writing and mail to the Judge whose name appears on your citation. Along with a copy of the citation(s), no later than the appearance date shown on the citation. You shall be notified by return mail of the court date set for your hearing. You have the right to a trial by jury if you so request.

If you wish to enter a plea of **GUILTY** or **NO CONTEST**, please so indicate in the proper space provided below. A plea of No Contest means that you do not contest the State's charge(s) filed against you. The fine for a No Contest plea is the same as the fine for a plea of Guilty. Either plea indicates that you agree to waive appearance before this Court for trial.

Please refer to the schedule shown on the reverse side of this letter to determine the total amount of your fine(s) and costs assessed against you. Make your remittance by: **CASHIERS CHECK OR MONEY ORDER (PERSONAL CHECKS NOT ACCEPTED), payable to Kendall County. If you wish to make payment with a credit card go to [www.Certifiedpayments.net](http://www.Certifiedpayments.net) and you will be asked for a Bureau Code. Each JP Office has a unique BUREAU CODE. Precinct 1 is 3740102; Precinct 2 is 6527765; Precinct 3 is 1617259; and Precinct 4 is 7229073.**

Return a copy of the citation and this letter with your remittance to assure proper credit. If you fail to respond to this charge by the appearance date shown on the citation, an additional charge will be assessed against you for violation of Promise to Appear with additional fees. Your prompt attention to this matter is imperative. Thank You.
