COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to grant relief from the platting requirements and road frontage in accordance to Sections 101 and 102 of the Kendall County Development Rules and Regulations. The proposed division would create five tracts ranging from (+/-) 6 acres to (+/-) 25 acres from a parent tract of 235 acres. The proposed tracts will be accessed over multiple 30-foot-wide private easements to FM 473 (Maxie and Donna Jonas).
