



To Whom it May Concern:

The replat of Hill Crest Block 6 Lot 5 & 6 located on 5th Street between Altgelt St and Faltin St. is seeking request for relief from the Kendall County Development Rules and Regulations and Kendall County Order 06-27-2016A. The proposed project is a high density, low impact community in which a strict interpretation of the provisions of the Kendall County Development Rules and Regulations and Kendall County Order 06-27-2016A would deprive the reasonable use of the land; thus, we are requesting relief of the following items:

- i. **Kendall County Order No 06-27-2016A Section 5.1**
 - a. A request for relief from the building setback and tract size listed in Kendall County Order No 06-27-2016A Section 5.1. We are requesting relief from the required 25-foot setback between the buildings and any property line or street, and relief from the 50 feet between any two structures. We are requesting a front set back of 10-feet, and a side setback varying from 0-feet up to 10-feet. Per 2015 International Residential Code Table R302.1(1) (Attachment A) and 2015 International Building Code Table 601 and 602 (Attachment B), the appropriate fire rating will be used in order to meet the reduced building setbacks in this community.
- ii. **Kendall County Order No 06-27-2016A 5.3.2**
 - a. A request for relief from the minimum Residential Class B street requirements set forth in Kendall County Development Rules and Regulations Section 400.2600 Table 400 (Attachment C). To minimize the site footprint, the travel path width of the proposed private gated road is to be 20-feet, within a 24-foot private ingress/egress, fire, water and sanitary sewer easement. The 20-foot travel path satisfies the required width according to 2015 International Fire Code Table D103.4 (Attachment D), for the fire apparatus access to the community. It is the intent of the developer to remedy this variance by providing driveway areas to park and no on-street parking, which will be marked with signage. Items above have also been discussed with Kendall County Fire Marshal.
- iii. **Kendall County Development Rules and Regulations Section 400.1400**



- a. A request for relief from the prohibition of dead-end streets listed in Kendall County Development Rules and Regulations Section 400.1400. The subdivision will be a private gated community and the street will not hinder any future development in the area. The length of the pavement from the property line to the end of the private road for the community will be approximately 160 feet, which is greater than the 150 feet required for the dead-end turnaround requirements (2015 International Fire Code D103.4 (Attachment D)). The street will be paved with curb and have the proper lighting and limit overhead obstructions in the apparatus path of access to the fire hydrant, with the respective fire line signage (2015 International Fire Code D103.6). In addition to the current fire hydrant located in the southeast corner of lot 5, a proposed fire hydrant is to be placed in the southwest corner of Lot 6. The items above have also been discussed with the Kendall County Fire Marshal.

c. Open parking garages complying with Section 406 shall not be required to have a fire-resistance rating.

d. The fire-resistance rating of an exterior wall is determined based upon the fire separation distance of the exterior wall and the story in which the wall is located.

e. For special requirements for Group H occupancies, see Section 415.6.

f. For special requirements for Group S aircraft hangars, see Section 412.4.1.

g. Where Table 705.8 permits nonbearing exterior walls with unlimited area of unprotected openings, the required fire-resistance rating for the exterior walls is 0 hours.

h. For a building containing only a Group U occupancy private garage or carport, the exterior wall shall not be required to have a fire-resistance rating where the fire separation distance is 5 feet (1523 mm) or greater.





