- 1. The meeting was called to order at 9:00 a.m. with the Pledge of Allegiance to the United States and Texas flags.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Minutes for May 26, 2009.

Motion was made by Commissioner Reissig, seconded by Commissioner Miertschin, and carried by a vote of 5-0.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Claims as submitted (on file).

Motion was made by Commissioner Lux, seconded by Commissioner Rusch, and carried by a vote of 5-0.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the November 2008, December 2008, and January 2009 Financial Statements as submitted (attached).

5. PUBLIC COMMENTS:

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to authorize the payment for Emergency Call Out for Road & Bridge.

17. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to authorize a Public Notice for a Public Hearing on June 22, 2009 at 9:15 a.m. regarding the proposal to increase the speed limit to 55 miles per hour on Ranger Creek Road beginning at Lake Boulevard going west and continuing through the entire length of Turkey Knob Road and also to approve a No Parking zone on Upper Cibolo Road from the centerline of Boerne Lake Road extending 1,200 feet east and 950 feet west.

Motion was made by Commissioner Rusch, seconded by Commissioner Lux, and carried by a vote of 5-0.

18. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to grant relief to platting requirements in accordance with paragraph 101.1000 of the Development Rules and Regulations dated August 29, 2005 (amended September 2006) and requiring the Affidavit of Land Location to note that any further division must meet the Kendall County Development Rules and Regulations. The proposed division of 50.41 acres off of Highway 289 adjacent to Holiday Creek will result in a 3-acre tract and a 47.41-acre tract (Victor Garate, President, GMI Development).

Motion was made by Commissioner Rusch, seconded by Commissioner Lux, and carried by a vote of 5-0.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to authorize the rental of certain areas of Joshua Springs Park and Preserve on a temporary basis providing that details can be worked out by the County Parks Director, the County Attorney, and the requesting party.

Motion was made by Commissioner Lux, seconded by Commissioner Rusch, and carried by a vote of 5-0.
