- 1. The meeting was called to order at 9:00 a.m. with the Pledge of Allegiance to the United States and Texas flags.
- 2. The following received Service Awards:

- 3. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Minutes for December 14, 2009.

Motion was made by Commissioner Reissig, seconded by Commissioner Miertschin, and carried by a vote of 5-0.

Ken Anderson said that he objected to the Court approving the Minutes for December 14, 2009 because he said that the Minutes do not accurately reflect his public comments during Court on that day.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Monthly Reports for November 2009 (on file).

Motion was made by Commissioner Lux, seconded by Commissioner Reissig, and carried by a vote of 5-0.

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Claims as submitted (on file).

6. PUBLIC COMMENTS:

- Ken Anderson said that he questioned the legality of some of the County's Development Rules & Regulations and asked the Court to submit the proposed Rules & Regulations to the Attorney General's Office for legal review since it is free and could prevent lawsuits against the County.
- 7. No action was taken on reinstating the burn ban. It is still off.

8. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve appointing Ann Reissig as the member of the Kendall County Commissioners Court to the Alamo Regional Rural Planning Organization Committee.

Motion was made by Commissioner Lux, seconded by Commissioner Rusch, and carried by a vote of 5-0.

- 9. A Public Hearing was held regarding the proposed installation of 4-way stop signs at the intersection of Joe Klar Road and Coveney Trail. The following people spoke:
 - Robert Comstock, Coveney resident, spoke in favor of the signage and presented a supporting petition to the Judge.
 - Mike Sheridan, Cordillera Ranch Development Vice President, asked if the County had done any traffic studies at that intersection and if so, what the results were; he said that safety is the first priority.
 - Commissioner Miertschin said that the study conducted by the Sheriff's Office supported the signage.
 - Tom Laurin, Coveney resident, spoke in favor of the signage.
 - Burl Hickman, Coveney resident, spoke in favor of the signage.
