

**WORDING OF AGENDA ITEM:** Consideration and action concerning order regulating electioneering on County property.

JUSTIFICATION (REASON ITEM SHOULD BE ON AGENDA): During the last legislative session, amendments were adopted to the Election Code that allows the Commissioners Court to regulate electioneering on County property and does not allow the prohibition of electioneering on County property where a polling location is situated during a voting period. At the meeting on January 13, 2014, a committee was appointed chaired by Commissioner Fincke to make recommendations to the Court concerning regulations to be contained in the order. The committee has met and its recommendations are contained in a proposed order (copy attached).

### **KENDALL COUNTY ORDER NO. 01-27-2014**

### ORDER REGULATING ELECTIONEERING ON KENDALL COUNTY OWNED PROPERTY AND BUILDINGS

WHEREAS, the Commissioners Court has control over all property and buildings owned by Kendall County; and

WHEREAS, Section 61.003, Texas Election Code provides that an entity that owns or controls a public building being used as a polling location during an election may not, at any time during the voting period, including the early voting period and election day, prohibit electioneering on the building premises outside of the area described in subsection 61.003(a), Texas Election Code; and

WHEREAS, Section 61.003, Texas Election Code provides that an entity that owns or controls a public building being used as a polling place during the voting period may adopt reasonable regulations concerning the time, place, and manner of electioneering;

NOW THEREFORE, the following Order is adopted regulating the time, place, and manner of electioneering on property and buildings owned by Kendall County, including buildings and property that is not being used as a polling location during a voting period and buildings being used as a polling location during a voting period. This Order is in addition to statutory requirements that restrict political activity within 100 feet of a polling location during a voting period. [See Texas Election Code, Section 61.003(a)].

#### Section 1. Definitions

- A. When used in this Order the following terms shall be defined as follows:
  - 1. "Early voting period" means the period prescribed by Section 85.001, Texas Election Code.
  - 2. "Electioneering" includes the posting, use, or distribution of political signs or literature.
  - 3. "Voting period" means the period beginning when the polls open for voting and ending when the polls close or the last voter has voted, whichever is later.
  - 4. "Polling location" means those buildings designated as locations where voters can cast ballots during a voting period.
- B. Terms not defined herein shall have the meaning as defined by the Texas Election Code.

### Section 2. Prohibitions and Regulations:

A. In County owned buildings and on County property and premises not used as a polling location, electioneering is prohibited except as set out herein.

- 1. Motor vehicles with bumper stickers supporting or opposing a candidate or issue will be permitted to park in County owned parking areas provided the owner/operator of the vehicle is present on the premises: (a) as an officer, agent or employee of Kendall County and is conducting County business on the premises other than electioneering; or (b) is a citizen on the premises for purposes related to County matters other than electioneering.
- 2. Motor vehicles with not more than two signs one sign located on each side of the vehicle, and each sign not being larger than three square feet (24 inches by 18 inches being the standard size) that support or oppose a candidate or issue will be permitted to park in County owned parking areas provided the owner/operator of the vehicle is present on the premises: (a) as an officer, agent or employee of Kendall County and is conducting County business on the premises other than electioneering; or (b) is a citizen on the premises for purposes related to County matters other than electioneering; and provided further that such signs are in compliance with state law.
- B. On the premises of a polling location beginning 24 hours prior to early voting and/or a voting period and continuing during the voting period or as set out herein:
  - As provided in the Texas Election Code, all electioneering is prohibited within 100 feet of a polling location. Such distance shall be measured from the entrance to a polling location where voters are allowed to enter for the purpose of voting. If there is more than one such entrance, the distance shall be measured from each such entrance.
  - At the Elections Office located at 221 Fawn Valley Drive in the City of Boerne, 2. signs limited in size to three square feet supporting or opposing a political candidate or issue may be posted in the designated area beginning 24 hours before the beginning of early voting. Such signs shall be removed within seven days following the election to which the sign relates and shall otherwise comply with state law and applicable city ordinances. (Note: Signs may be placed in the area adjacent to the sidewalk along Commercial Drive and within an area extending for a distance of five feet from the sidewalk. Signs may not be placed in the right-of-way of city streets or state highways. The wood fence on the northwest side of the property adjacent to Commercial Drive is in the right-of-way and signs are not allowed on the fence. Signs may be placed outside the right-of way of Fawn Valley and State Highway 474 and within an area extending five feet from such right-of-way. Signs may be placed adjacent to the parking area and within an area extending five feet from the parking area into the grassy area. Signs may not be posted in the parking area. Signs placed in unauthorized areas will be removed.)
  - 3. At all polling locations, (including polling locations for early voting and polling locations for election day), electioneering may be conducted subject to the following regulations:
    - a. Signs limited in size to three square feet may be posted in designated areas beginning 24 hours before the beginning of the voting period. Such signs shall be removed within seven days following the end of the voting period. (Note: Generally, the area allowed for posting signs will be adjacent to any

sidewalk, parking area or road right-of-way and extending for an area five feet from the sidewalk, parking area or road right-of-way, provided such area is outside of the 100 feet prohibited area. Signs may not be posted in the right-of-way of streets or roads. Signs must be located outside of any parking area. Signs placed in unauthorized areas will be removed.)

- b. Motor vehicles with bumper stickers supporting or opposing a candidate or issue will be permitted to park in the parking area outside of the 100 feet area, provided the owner/operator of the vehicle is present on the premises:

  (a) as an officer, agent or employee of Kendall County and is conducting County business on the premises other than electioneering; or (b) is a citizen on the premises for purposes related to County matters other than electioneering.
- c. Electioneering will be permitted within designated areas provided state law and any applicable city ordinances are followed and provided further that such electioneering shall not result in an obstruction of a sidewalk, driveway, parking area, passageway, or entrance used by voters or the public generally. (Note: Generally, electioneering will be allowed in the areas where the posting of signs and location of shelters is permitted. Electioneering is not permitted in parking areas.)
- d. No vehicles, trailers buildings, or structures of any type will be allowed on the premises except as set out herein. Shelters, awnings, umbrellas, and similar coverings of a flexible material and portable nature with a surface area of not more than 10 feet by 10 feet (100 square feet) for the protection of persons from the sun and weather may be erected daily in designated areas beginning 30 minutes prior to a voting period and may remain on the premises for one four following the end of the voting period daily. No grills, barbeque pits or other cooking devices shall be allowed on the premises. Reasonable size coolers, water, non-alcoholic beverages, and food will be allowed on the premises daily for the use of candidates, their volunteers, and workers only. No food, water or beverages will be distributed to voters or the public generally. Suitable chairs, stools, benches, and tables for the use of candidates, their volunteers, and workers are permitted in designated areas beginning 30 minutes prior to a voting period daily and may remain on the premises for one hour following the end of the voting period daily. Erection and location of shelters and other permitted items shall be done so that there is no damage to County property or surrounding property. (Note: At the Elections Office on Fawn Valley, shelters, tables and chairs may be located outside of the area designated for the posting of signs - the five feet wide area adjacent to the sidewalk, parking area and street/road right-of-way. Such shelters, tables and chairs should be placed so that they do not obstruct the passage of voters and the public generally. No shelters, tables or chairs will be allowed on the parking area.)
- e. Littering is prohibited. Each candidate is responsible for ensuring that all garbage, trash and debris is contained in a sanitary manner and removed from the premises daily.

f. Due to the need for voters, election officials and others lawfully on the premises to conduct County business other than electioneering to have sufficient parking areas for their motor vehicles, candidates, their volunteers, and workers shall not park their motor vehicles on County parking areas but should park their motor vehicles in legal areas off of County premises. If possible, alternative parking areas will be designated prior to a voting period.

SECTION 3. PENALTIES: Violation of this Order is subject to penalties applicable to all orders adopted by the Commissioners Court. In addition, violators may be required to depart polling location premises and remove all electioneering materials from the premises.

**SECTION 4. REPEAL OF CONFLICTING ORDERS**: All prior orders adopted by the Commissioners Court which are in conflict with this Order are hereby repealed.

**SECTION 5. SEVERABILITY:** Should any provision of this Order be held invalid, void, or unenforceable by a court or authority of competent jurisdiction, such invalid, void, or unenforceable provision shall be severed from this Order and the remaining and unaffected provisions of this Order shall remain in full force and effect.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. The heading to Section 61.003, Election Code, is amended to read as follows:

Sec. 61.003. ELECTIONEERING AND LOITERING NEAR POLLING PLACE [PROHIBITED].

SECTION 2. Section 61.003, Election Code, is amended by adding Subsection (a-1) and amending Subsection (b) to read as follows:

(a-1) The entity that owns or controls a public building being used as a polling place may not, at any time during the voting period, prohibit electioneering on the building's premises outside of the area described in Subsection (a), but may enact reasonable regulations concerning the time, place, and manner of electioneering.

### (b) In this section:

- (1) "Electioneering" includes the posting, use, or distribution of political signs or literature.
- (2) "Voting [, "voting] period" means the period beginning when the polls open for voting and ending when the polls close or the last voter has voted, whichever is later.

SECTION 3. The heading to Section 85.036, Election Code, is amended to read as follows:

Sec. 85.036. ELECTIONEERING [PROHIBITED].

SECTION 4. Section 85.036, Election Code, is amended by adding Subsections (b) and (f) to read as follows:

(b) The entity that owns or controls a public building being used as an early voting polling place may not, at any time during the early voting period, prohibit electioneering on the building's premises outside of the area described in Subsection (a), but may enact reasonable regulations concerning the time, place, and manner of electioneering.

### (f) In this section:

- (1) "Early voting period" means the period prescribed by Section 85.001.
- (2) "Electioneering" includes the posting, use, or distribution of political signs or literature.

SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2013.

### Letter Opinion No. 96-035

Re: Whether a county commissioners court is authorized under Local Government Code section 381.001(f) to donate county tax funds to a nonprofit organization whose purpose is to assist industrial development (RQ-852)

### Dear Mr. Braziel:

You ask whether a county commissioners court is authorized to donate county tax funds to a nonprofit organization whose purpose is to assist industrial development. You state that Rains County has a county industrial commission and ask whether the donation is authorized by section 381.001(f) of the Local Government Code.

Section 381.001 authorizes the county judge of a county to appoint a county industrial commission. Subsection (f) provides that "[t]he commission shall investigate and undertake ways of promoting the prosperous development of business, industry, and commerce in the county. The commission shall promote the location and development of new businesses and industries in the county and the maintenance and expansion of existing businesses." Article III, section 52 of the Texas Constitution is also relevant:

Except as otherwise provided by this section, the Legislature shall have no power to authorize any county . . . of the State to lend its credit or to grant public money or thing of value in aid of, or to any individual, association or corporation whatsoever, or to become a stockholder in such corporation, association or company.

You appear concerned that section 381.001 of the Local Government Code does not authorize the county to donate county tax funds to a nonprofit organization whose purpose is to assist industrial development, perhaps because section 381.001(f) does not appear to authorize a county, as opposed to a county industrial commission, to promote economic development. We do not reach your statutory question, however, because we conclude that the Texas Constitution precludes the county from making donations of any sort.

In Attorney General Opinion <u>H-397</u>, this office concluded that article III, section 52 of the Texas Constitution prohibits a county from paying dues to a chamber of commerce. Attorney General Opinion <u>H-397</u> (1974) at 2. We construe Attorney General Opinion <u>H-397</u> to interpret article III, section 52 to prohibit political subdivisions such as counties from making outright gifts and donations to private entities. See Kordus v. City of Garland, 561 S.W.2d 260, 261 n.1 (Tex. App.--Tyler, 1978, writ ref'd n.r.e.) (holding that Texas Constitution prohibits city from making donations and gifts to private corporations) (citing Attorney General Opinion <u>H-397</u> (1974) with approval).

Article III, section 52-a, adopted in 1987, makes certain exceptions to section 52, providing in pertinent part as follows:

Notwithstanding any other provision of this constitution, the legislature may provide for the creation of programs and the making of loans and grants of public money, other than money otherwise dedicated by this constitution to use for a different purposes, for the public purposes of development and diversification of the economy of the state, the elimination of unemployment or underemployment in the state . . . . An enabling law enacted by the legislature in anticipation of the adoption of this amendment is not void because of its anticipatory character.

In Attorney General Opinion <u>JM-1227</u>, this office concluded that section 52-a was intended to create exceptions to pre-existing constitutional prohibitions on the lending of public credit by political subdivisions, but also concluded that it "does not itself expand the authority of [political subdivisions] to lend credit; it merely authorizes the legislature to do so. Consequently, enabling legislation would be necessary to authorize the transaction in question." Attorney General Opinion JM-1227 (1990) at 2.

The statutory predecessor to section 381.001 of the Local Government Code was first enacted in 1971. Act of May 26, 1971, 62d Leg., R.S., ch. 975, § 1, 1971 Tex. Gen. Laws 2947, 2947-48. Although section 381.001 was codified in 1987 as part of a nonsubstantive codification, Act of May 1, 1987, 70th Leg., R.S., ch. 149, §§ 1, 51, 1987 Tex. Gen. Laws 707, 1308, it has not been substantively amended since before 1987. We conclude that section 381.001 is not intended as an enabling law under section 52-a. Cf. Attorney General Opinion DM-185 (1992) (concluding that Local Gov't Code § 380.001, enacted in 1989, is intended to authorize cities to undertake activities permitted by Tex. Const. art. III, § 52-a). Therefore, even assuming that section 381.001(f) could be construed to authorize a county, as opposed to a county industrial commission, to promote economic development, we believe that any action

undertaken pursuant to section 381.001(f) is subject to the strictures of article III, section 52. Thus, in answer to your query, article III, section 52 of the Texas Constitution prohibits a county commissioners court from making outright gifts or donations of any sort pursuant to section 381.001(f), including a donation of county tax funds to a nonprofit organization whose purpose is to assist industrial development.

### SUMMARY

Article III, section 52 of the Texas Constitution prohibits a county commissioners court from making a donation of county tax funds pursuant to Local Government Code section 381.001(f) to a nonprofit organization whose purpose is to assist industrial development.

### Footnotes

1. Political subdivisions may transfer public funds to private corporations under certain circumstances without running afoul of this constitutional prohibition. As one court has noted in a case involving the transfer of county funds to a private nonprofit corporation, article III, section 52 does not prohibit all such transfers but rather requires that they serve a public purpose and that "to insure that the political subdivision receives its consideration, viz., accomplishment of the public purpose, the political subdivision must retain some degree of control over the performance of the contract." Key v. Commis-sioners Court, 727 S.W.2d 667, 669 (Tex. App.--Texarkana, 1987, no writ) (quoting Mike Willatt, Constitutional Restrictions on Use of Public Money and Public Credit, 38 TEX. B.J. 413, 422 (1975)). All transfers of county funds or property to a private entity must satisfy this constitutional test. In Attorney General Opinion JM-516, for example, this office concluded that a county may contract for industrial development services with a private corporation under certain conditions, that is, that the contract serve a public purpose and provide sufficient assurance that the public purposes will be accomplished, and that the county receive adequate consideration. Attorney General Opinion JM-516 (1986) at 2. Although this office has on occasion stated that certain types of "donations" are permissible under article III, section 52, the use of the term "donation" in connection with such expenditures is a misnomer. See, e.g., Attorney General Opinion DM-268 (1993) at 3 (concluding that county "donation" of salvage or surplus property to private organization will not run afoul of article III, section 52 if it serves public purpose and is accompanied by adequate consideration); Letter Opinion 94-008 (1994) at 4 (home rule city may "donate" public money to private nonprofit corporation provided that city determines that expenditure serves a legitimate

public purpose and places sufficient controls on transaction to ensure that public purpose will be carried out).

- 2. You ask only about Local Government Code section 381.001(f). You do not ask about Local Government Code section 381.004. Therefore, we do not address whether section 381.004 was enacted in order to implement article III, section 52-a of the Texas Constitution, see Attorney General Opinion <u>DM-185</u> (1992) at 4-5 n.2, or whether section 381.004 authorizes the county expenditure you describe.
- 3. Article III, section 52, however, does not prohibit a county from transferring county funds to a private entity provided that the expenditure serves a public purpose, that the county receives adequate consideration, and that there are sufficient controls to ensure that the public purpose will be accomplished. While it might be possible to insure sufficient controls without a formal contract, the ordinary and most prudent method of establishing such enforceable controls would be by contract.

### Opinion No. JM-516

Re: Validity of a contract between Nueces County and an economic development corporation

Dear Mr. Valdez:

You have requested an opinion on the following question:

Taking into consideration the fact that a county cannot be a dues-paying member of a chamber of commerce, does Nueces County have the authority to contract for business or industrial development services with a corporation that will in essence be an agency of a chamber of commerce?

A county's authority to enter into a contract is limited to authority conferred on it, either expressly or by reasonable implication, by the constitution or statutes. Canales v. Laughlin, 214 S.W.2d 451, 453 (Tex.1948). A county has authority to promote the development of businesses and industries in the county through a county industrial commission established under article 1581g-2, V.T.C.S., or through a board of development established under article 2352d, V.T.C.S. A county may contract for services that the county is authorized to perform itself. Attorney General Opinion JM-65 (1983). Therefore, under articles 1581g-2 and 2352d, a county has authority to contract for business or industrial development services.

You are concerned, however, about the relevance of a 1974 attorney general opinion that concluded that a county could not pay dues to a chamber of commerce. Attorney General Opinion H-397 (1974). In that opinion, this office held that article III, section 52, of the Texas Constitution prohibits a county from becoming a dues-paying member of a private corporation such as a chamber of commerce. Article III, section 52, provides, in part:

Except as otherwise provided by this section, the Legislature shall have no power to authorize any county, city, town or other political corporation or subdivision of the State to lend its credit or to grant public money or thing of value in aid of, or to any individual, association or corporation whatsoever, or to become a stockholder in such corporation, association or company.

That provision does not prevent counties from contracting with private corporations. Attorney General Opinion <u>JM-65</u> (1983). Rather, it prohibits gifts to a private corporation. As a corollary, it requires that a county contract with a private corporation serve a public purpose and that the county receive adequate consideration. Attorney General Opinion <u>MW-373</u> (1981). Also, such a contract must provide sufficient assurance that the public purposes will be accomplished. Id.; Attorney General Opinion H-912 (1976).

In Attorney General Opinion H-397 this office concluded that paying dues to a private corporation such as a chamber of commerce in order to secure "general benefits resulting from encouragement of private industry and business" was not "sufficiently insulated from the abuses" that article III, section 52, was designed to prevent. Implicit in that conclusion is a determination that paying dues to a chamber of commerce did not adequately assure that any public purpose would be accomplished and therefore that the dues would be, in essence, a gift to the private corporation.

A contract for specific services presents a different situation. For purposes of article III, section 52, the difference between paying dues to an organization that may provide general benefits to the county and contracting with an organization for specific services is analogous to the difference between donating county funds to a private hospital and contracting with a private hospital for specific services. In Attorney General Opinion JM-65 (1983) we held that although a county could not donate funds to a private hospital, it could contract with a private hospital for specific services. Similarly, we think that a county may contract with a private corporation for business and industrial development services. Of course, the county must receive adequate consideration, and the contract must provide adequate assurance that the public purpose will be accomplished. Whether a county receives adequate consideration and whether a contract provides adequate assurance that its public purpose will be accomplished are questions of fact that would depend on the nature of any particular contract.

### **SUMMARY**

A county has authority to promote the development of business and industry in the county under article 1581g-2, V.T.C.S., and article 2352d, V.T.C.S. A county may contract with a private corporation such as a chamber of commerce for the provision of business and industrial development services if the county receives adequate consideration and if the contract provides adequate assurance that the public purpose will be accomplished.
