COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Final Plat of Unit 207D, Cordillera Ranch, in accordance with Section 203 of the 1990 Kendall County Regulations, Rules and Specifications for Roads and Subdivisions. The proposed subdivision consists of 11.01 acres, 8 residential lots, and 1,368 linear feet of roadway for a density of 1.33 acres per lot and will be served by a central water and sewer system.

## 27. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, to approve the Final Plat of Unit 207C-1, Cordillera Ranch, in accordance with Section 203 of the 1990 Kendall County Regulations, Rules and Specifications for Roads and Subdivisions. The proposed subdivision consists of 10.94 acres, 8 residential lots, and 630 linear feet of roadway for a density of 1.37 acres per lot and will be served by a central water and sewer system.
