## 5. THE STATE OF TEXAS

COUNTY OF KENDALL It is ordered by the Commissioners' Court of Kendall County, Texas, that the property tax rate be increased by the adoption of a 2022 tax rate of \$0.38770, which is effectively a 10.60 percent increase in the tax rate. The 2022 tax rate includes the Debt Service Rate of \$0.094420 and the Maintenance and Operations Rate of \$0.293280.

This year's tax levy to fund maintenance and operations expenditures does not exceed last year's maintenance and operations tax levy.
