WHEREAS, Tex. Loc. Gov't Code Ann. § 262.037 requires that an officer authorized to make a purchase on behalf of the County or County department/office may not make any purchase until providing to the County Judge a signed acknowledgment that the officer has read and understands Tex. Loc. Gov't Code Ann. §§ 262.001, et. seq., as amended; and

WHEREAS, the Commissioners Court finds that by appointing the County Judge as an agent to make contracts on behalf of the County for purchases of \$50,000 or less will save the County significant time and resources; and

WHEREAS, the Commissioners Court finds that by adopting this Order, Kendall County will be in compliance with Tex. Loc. Gov't Code Ann. §§ 262.001, et. seq., as amended.

NOW, THEREFORE, the following ORDER is adopted and effective immediately:

- 1. All expenditures of \$50,000 or less that require the County to execute a contract must be reviewed by Kendall County's Office of General Counsel and signed by General Counsel noting "Approved As To Legal Form."
- 2. The Kendall County Auditor must sign the contract with the Auditor's Certificate confirming that the department/office has money budgeted for the expenditure as required by Tex. Loc. Gov't Code Ann. § 113.043.
- 3. After obtaining signatures from the County Auditor and General Counsel, the contract may be executed by the County Judge.
- 4. By requiring legal review prior to presenting to the County Judge for execution, the County will comply with Tex. Loc. Gov't Code Ann. § 262.037.

WHEREAS, the Commissioners Court of Kendall County must approve, by an order entered in the minutes of the court, a plat required by Tex. Loc. Gov't Code Ann § 232.001; and

WHEREAS, the Commissioners Court may impose a plat application fee to cover the cost of the County's review of the plat as provided by Tex. Loc. Gov't Code Ann § 232.0021; and

WHEREAS, the Commissioners Court has the authority to delegate plat approval responsibility as provided by Tex. Loc. Gov't Code Ann § 232.0022; and

WHEREAS, in the past, deeds, subdivisions of property, and other instruments affecting property were approved by Commissioners Court that were incorrectly approved and recorded in the Kendall County Clerk's Office resulting in incorrect or inaccurate information being reflected in the County's official public records; and

WHEREAS, the Commissioners Court desires to provide an expedited process for approval of plat corrections or plat amendments which merely reflect such existing situations in order to ensure that County records correctly indicate existing situations and to save the citizens of Kendall County unnecessary delay and expense; and

WHEREAS, in areas within Water Control and Improvement District Number 1 ("WCID 1") may be served by Central Water and Central Sewer; and

WHEREAS, amending plats or plat revisions have been prepared for property within the Town of Comfort and within WCID 1 and previously filed in the County Clerk's office; and

WHEREAS, these plats were incorrectly processed as amending plats or plat revisions when a new plat should have been submitted.

NOW THEREFORE, the following Order is adopted, effective immediately, concerning existing situations where deeds, subdivisions of property, and other instruments affecting property were recorded in the Kendall County Clerk's Office:

- 1. In areas served by a Water Control and Improvement District, the Commissioner of the Precinct where the property is located and the Kendall County Engineer are authorized to approve the plat, plat amendment, or plat revision and waive the plat review fee, in accordance with the Kendall County Development Regulations.
- 2. The Commissioner of the Precinct and the County Engineer shall approve the plat and certify that the plat is correct.
- 3. After approval, the instrument shall be filed in the County Clerk's records.
- 4. To the extent that this Order conflicts with any prior Order adopted by Commissioners Court, this Order controls.

Motion was made by Commissioner Carpenter, seconded by Commissioner Chapman, and carried by a vote of 5-0.
